Sub: - Direction under section 33'A' of Water (Prevention and Control of Pollution) Act, 1974 and under section 31'A' of Air (Prevention and Control of Pollution) Act, 1981.

Whereas no person shall, without the prior consent of the State Board, operate any industry in pollution control area, as per the provisions of Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 (herein after referred as Water Act and Air Act respectively).

Whereas, you are operating Rice Mill Unit at Village-Barpali, Tehsil-Barpali, Dist- Korba (C.G) without having valid consent from the board and against the relevant environmental laws.

Whereas, it is mandatory to apply for consent before establishment of the industry and you had not applied for the same till date.

Whereas, during the inspection on 21.07.2025, your unit was inspected by the officials of the board and following points were observed:-

1. The unit is being operated without obtaining consent of the Board.

Whereas, it has been directed by Head Office vide letter under reference no. 01 to ensure that no industry shall operate without having valid consent/renewal from the Board.

Now therefore in exercise of power conferred upon under section 33 'A' of Water Act and under section 31 'A' of Air Act, this office direct as follows:-

1. That you shall close the Rice Mill Unit forthwith.
2. That the concerned authorities shall disconnect the supply of electricity, provided to the above unit or seize D.G. Set through which industry is operating, with immediate effect.
3. That you shall not restart the unit, until valid consent from the board as per provisions of Water and Air Act has been obtained.

In case you fail to comply with the directions, you are liable for action inter-alia under section 41 of the Water Act and under section 37 of the Air Act.
